BOOK REVIEW AGREEMENT

Between: Pacific Affairs
A Division of the University of British Columbia
(hereinafter "PA")

And: Dr. Hyung-Gu Lynn
(hereinafter the "Reviewer")

WHEREAS the Reviewer is requested from time to time to create and provide book reviews to PA (each instance of which is a "Review" or collectively the "Reviews").

AND WHEREAS PA wishes to obtain rights with respect to the Reviews created during the term of this agreement.

IT IS AGREED THAT:

1. In consideration of a copy of the book for each Review and other good and valuable consideration, the Reviewer grants, assigns and transfers exclusively to PA for its use all rights, title and interest of whatsoever kind or nature, now or hereafter protected by the copyright laws of any country in any language, in and to the Reviews, including all subsidiary rights. The Reviewer hereby waives all his or her moral rights in the Reviews.
2. PA agrees to accede to any request by the Reviewer to use part or all of his or her Reviews, subject only to suitable acknowledgement of its first appearance, in a work under his or her exclusive authorship or editorship. In such cases, no reprinting fee shall be payable to PA.
3. The Reviewer agrees to refer to PA any requests to publish any Review, or a major portion thereof, in other journals, or in works of which he or she is not exclusive editor. PA will normally accede to requests from educational institutions to reprint the Review for non-commercial classroom use, without prior notification to the Reviewer.
4. The Reviewer warrants that each Review will be original and will not have previously been published elsewhere, in whole or in part, in substantially the same form. The Reviewer warrants that permission to publish the Reviews has not been granted to any other person.
5. The Reviewer warrants that each Review contains no defamatory or otherwise unlawful material and that it makes no improper invasion of the privacy or personal rights of anyone.
6. In the event of any claim, action, or proceeding based on a violation of any of the Reviewer's warranties in this agreement PA shall have the right to defend the same through counsel of its own choosing. The Reviewer agrees to pay all resulting costs and damages, except that this indemnity shall not apply to any material that the Reviewer advises PA in advance of publication might be construed as defamatory or otherwise unlawful.
7. Notwithstanding the date of execution of this agreement, this Agreement shall apply to all Reviews submitted to PA from January 1, 2001 to December 31, 2003.
8. This agreement shall enure to the benefit of and be binding upon the parties and their successive heirs, executors, administrators, successors.
